Terms and Conditions

1. The Petro Card shall be honored at select GAPCO (Sudan) Ltd. retail outlets (Petrol outlet).
2. The card will be issued only to individuals above 18 years of age.
3. The application form for enrolment will be available at GAPCO (Sudan) Ltd RO and has to be filled in and handed over the station manager with 15 SDG in cash as min
4. The card can be collected by the customer with 7 working days of depositing the complete application form the RO.
5. The card will have the electronic equivalent of the cash loaded on it which will be referred to as e-cash. The amount to be loaded on the card will have to be deposited in cash at the main offices
6. The e-cash is a payment towards future purchases.
7. The Petro Card can be utilized for the purchase of benzene and gas-oil only.
8. The minimum loading amount at each time would be 100 SGD and any additional amount desired to be loaded would be in multiples of 100 SDG.
9. The card is not transferable and intended for personal use only. Any liability arising due to card loss, misuse, or out of sharing of PIN consciously or otherwise, would render the card holder liable for all losses.
10. The card holder will be solely responsible for the inconvenience or inability to use the card.
11. The card holder needs to take adequate precautions to protect the card and prevent damage. Replacement of cards will be at the cost of 50SDG /- irrespective of the reason for damage.
12. Loss of the card should be intimated to GAPCO (Sudan) limited company immediately. GAPCO (Sudan) limited company immediately shall arrange to hot-list the card within 48 hours. However GAPCO (Sudan) limited immediately shall not be liable for any misuse whatsoever during the interim period.
13. If the lost hot listed card is subsequently found, it cannot be de-hot listed and the card holder will have to apply for a replacement card.
14. A transaction slip would be generated at the time of transaction which should be checked for accuracy of details. Any dispute on the debits can be verified and corrective action taken only if the transaction slip is provided to GAPCO (Sudan) limited (Sudan) limited company immediately shall be introducing a variety of reward schemes from time to time. These will be intimated as and when introduced.
15. GAPCO (Sudan) limited reserves the right to reject any application at its sole discretion.
16. The customer permits BPCL to use the information provided in the application form for issuance of the card in database activities. However, BPCL would ensure confidentiality.
17. All telephone instructions received and verified by two unique identifiers shall be deemed proper and GAPCO (Sudan) limited shall not be liable for executing these instructions in good faith. All such telephone instructions will be treated as having been written and signed.
